

Present: Mitchell, Evelyne, Robert, Yann

Agenda was previously emailed to everyone several days before.

Mitchell opened the meeting as everyone joined in.

Minutes of last meeting were reviewed with to do items discussed later.

Evelyne made a motion to accept minutes (12/15/2014) with Robert second. Minutes approved.

Since it has been a while since our last meeting there was a lot of personal talk to catch up on. If anyone missed these conversations and would like greater detail that I feel appropriate to comment here, please contact individually.

Briefly:

- Evelyne has had a challenging year on several fronts that has her distracted from N.O.T. activities in general. She completed the first of a three year educational course to obtain further accreditation.
- Robert has also had some health issues that are resolving at this point.
- Yann mentioned that France, especially Paris is still in the mist of turmoil from the recent terrorist activities there. People are feeling a bit paranoid and we all hope thing return to normalcy soon.
- Mitchell reported that he/I am doing well, working longer office hours and keeping busy with website updates and continuing with the monthly research reports. The monthly research reports do get quite a bit of activity ranging from 80 to 180 hits monthly. Attached is a 3-month summary report of website hits for your perusal.

Further discussions:

1. It was suggested to Evelyne that there should be a reference to the lifelong work of Dr. Ferreri in Wikipedia with a direct link to our website. This could serve to eliminate some of the confusion to the public as to which organization is the official one representing N.O.T. .

Evelyne has a contact that she can explore to possibly make this happen. The board should create, review and unanimously approve whatever ends up in Wikipedia if we are successful in this venture.

2. Robert will make a concerted effort to contact a local New York ICAK teaching diplomate whom he has taken some seminars with to ask what it takes to create a CEU seminar teaching N.O.T., i.e. licensing board requirements and fees in New York area. Robert will also ask what if any copyright issues may be involved if any future N.O.T. manual contains pictures and or direct quotes from published ICAK materials, (i.e. David Walters etc.). Evelyne mentioned of a website called <http://www.daz3d.com/> to possible obtain anatomical pictures.

I know in California there are extensive requirements in submitting a full and thorough teaching outline that has to approve by the Board of Examiners as well as hefty annual fees. Additionally CEU seminars are sponsored commonly by chiropractic schools, state associations or nutritional companies. These prior three options would be a challenge for N.O.T.

3. Evelyne created a group network on the Whats App international cell phone application which will allow ease of communication especially simple texting. This could be used for informal Board communications and reminders for upcoming Skype meeting.

  - Having more frequent Skype meetings
  - Completing the unfinished goals of our March 2014 Paris meeting.
